MINUTES OF THE MEETING HELD ON FRIDAY, AUGUST 8TH, 2020, OUTSIDE THE JERRY DAWSON PAVILION. .

1. Code of conduct (Declaration of Interest)

2. Apologies for absence

3. Police report

Coun. Towneley had held a meeting with the chairman of Briercliffe and Worsthorne Parish Councils regarding the Land Rover. The Land Rover is now fully operational and the bill for the repairs is to be split three ways. A log is to be kept when the vehicle is used. PCSO Mark Hill has been assigned as a designated rural PCSO and he will alternate between the 3 parish council meetings.

5. Minutes of the last meeting and matters arising

These were accepted, along with the updates provided during the lockdown...

5 (a) New sign at Mereclough Memorial Garden

Coun. Towneley is dealing with this and is to arrange for a wooden sign to be put up.

6. Allotments

Coun. Whittle to organise a new hose pipe junction.

It was agreed to raise the annual rent by £5 to cover ongoing maintenance. Also to give notice to one allotment holder and to ask a further one of their intentions, as there is a waiting list. It was agreed to look at the internal fencing and to weedkill where vegetation is getting through the exterior fencing onto a private householder's property.

6 (a) Councillors' reports

Various councillors raised a problem of spillage on the road at Overtown.

Coun Heys said the field by the layby just down from The Holme was being used a toilet and rubbish is being regularly burnt at the entrance to The Holme.

He said an advisory sign opposite The Hollins had been removed. The clerk to contact LCC.

Coun. Emo said he had received concerns of people speeding on Greencliffe Lane.

He said he had cleaned up the boundary stone at Red Lees Road and the area around it and a new bin has been installed. It was agreed the stone now looks in good order. The wording and a red rose need painting and the actual stone needs pointing. Coun. Heys offered to assist with both and is to liaise with Coun. Emo. It was also agreed that Coun Emo look at cleaning up the mile stones, an old boundary sign and contact Duncan Armstrong to replace the missing finger on the fingerpost on School Lane.

Coun. Towneley said a private company has been using the playing fields for private one to one football tuition. She is to find out who the company is and ask for a donation towards the upkeep of the pavilion.

She had also reported twice to LCC, a fracture of the highway by the bus stop on the Cliviger/Portsmouth border.

Coun. Briggs had removed some overgrowing vegetation which was blocking people's way near Broad Ing.

Coun. Whittle raised the problem of cars parking on the pavement outside JJ Diner. It is understood the business is moving to new premises.

Coun. Smith had reported a street lamp out on Burnley Road and she said the traffic lights at the Todmorden Road/Bacup Road are not working properly.

She raised problems of youths in the council grit yard and Coun. Towneley said LCC has upgraded its security there.

Coun. Towneley said Honeyholme Lane needed clearing of vegetation and this could be a good use of the £500 funding. She is to liaise with the lengthsman and obtain a price.

9 Scottish Power Community Benefit Fund

The panel had met and successful applications for funding were made by Cliviger Village Hall, Mount Zion Church and St John the Divine Church. Applications from the Shiva Trust and Burnley and Pendle Marie Curie fund raising group were turned down. A request for more information was made by the independent panel for an application by the parish council for the second stage of the Reap as You Sow project and funding for a Burnley Bridleway Association project is on hold for operational clarification.

Due to the new officials on the council, the signatories on the fund are to be changed.

Scottish Power is looking at ways of involving the community more in the fund.
