4. Questions from residents

Mr R Baldwin attended to discuss the administration of the Scottish Power Community Benefit Fund. It was agreed that further details will be forwarded to Mr Baldwin in a move for him to take over the admin.

Mr Steve Reid of The Kettledrum gave details of a jazz festival to be held on the Queen's Jubilee weekend and assured councillors that all the relevant planning had been done to ensure minimum disruption for neighbours. Councillors welcomed the event.

(a) New sign at Mereclough Memorial Garden

Coun Towneley to sort out the return of the benches from the borough council parks department . The sign to be purchased in the New Year.

(b) Mount Lane playing fields lease

Coun. Towneley has met with LCC legal team and the matter is moving on. Concern was expressed that the parish council would have to pay for repairs to the broken fencing around the field, if the lease was passed to the parish council. The school have sent in dates for the provisional sporting events for 2022.

(c) Park Road pavilion

EON has inspected the pavilion and the fault appears to be a power supply issue. The clerk has contacted Electricity North West to inspect.

(d) Fencing near the garage

The fencing needs looking at by the banking. Coun. Towneley to contact LCC.

(e) Milestones

Work is due to start in early 2022. The heritage expert, Mr Shane Johnstone is to apply for funding from the arts council for the project to create a special jubilee milestone in conjunction with Burnley Civic Trust, Cliviger School, Cliviger Archives and a local artist. The parish council has agreed to be the partner for the project.

(f) Utility work on Burnley Road

The work is ongoing and there are concerns now about the slowness of the traffic light displays at the corner of Red Lees Road and Burnley Road.

(g) Deer signs

Coun Emo said the police advised not to put up deer warning signs as it alerts poachers to areas.
