**Part 1**

**Disclosable Pecuniary Interests**

a Member/co-opted Member of Cliviger Parish Council

GIVE NOTICE that I have the following Disclosable Pecuniary Interests (please state 'None' where appropriate):

**Employment, office, trade, profession or vocation**

Any employment, office, trade, profession or vocation carried on for profit or gain.

I am in full-time paid employment, in the role of 'Client Manager', working for an organization called 'British Standards Institution'. I have held this role for approximately 20 years.
