MINUTES OF THE MEETING HELD ON FRIDAY.MAY 10TH. 2024. IN CLIVIGER VILLAGE HALL

LCC road safety is to carry out further data checks on Red Lees Road, Bacup Road and Todmorden Road.

6 Minutes of the last meeting and matters arising

These were accepted.

(a) Land off Richmond Avenue

Damage concerns have now been dealt with.

(b). Mount Lane pavilion

No official update. BBC has cut the school grass, but not the parish council end, Coun Emo to speak to parks. The pavilion is to be used for sports day in May.

(b) Miller Homes

No update on the ramp planning application.

(d) Transfer of land at Mereclough

Still progressing.

(e) Tipping on Long Causeway

LCC officials have visited the site and are considering what action needs taking.

(f) Collapsed utility cover on Red Lees Road

Repair work has been undertaken, but the contractors had left a mess behind.

(a) Broken bench at Overtown and by The Ram

Coun Emo to arrange for the broken bench to be removed and the one by The Ram to be looked at.

(h) Flag at the war memorial

This has now been replaced.

(i) Planters

BBC quoted £60 per planter, which each requiring 7 perennials, each in 2 litre pots and interplanted with summer bedding and trailing plants, with the perennials being allowed to grow and fill the planters. Spring bulbs would be planted at the appropriate time. Watering would be the parish council's responsibility and the planter by the garage will be moved to RACA park. This was agreed.

7. Allotments

A meeting of the allotment holders had been held and the rent increase, water supply, tree boundary work, all discussed. The parish council is to hold update meetings when appropriate and purchase a private sign and small noticeboard.

7 (a) Councillors' reports

Coun Bennett asked about the advertising sign at the former Fighting Cocks site. This has been put up by the purchaser of the site and is on private land. No planning application for the site has been submitted yet.

Coun Launer reported road problems on Park Road due to bad parking/delivery vehicles, Coun Towneley to arrange for the traffic warden to attend. Also an area has been cordoned off at the bottom of Park Road due to a weak path which is being investigated by LCC.

Coun Emo reported footpath problems at Bridge End, Coun Towneley to investigate. He said the Covid memorial tree at Salterforth Lane is still not responding to treatment.
